DRIVING UNDER INFLUENCE OF ALCOCHOL

Officers responded to the 2800 block of Mayfair Avenue shortly after midnight for a report of a loud crash. Officers located a disabled pickup truck with significant front-end damage and later discovered a parked vehicle that had also been struck.

During the investigation, officers observed signs of alcohol impairment from the driver, who admitted to consuming alcohol and refused field sobriety testing. An open container of alcohol was also observed inside the vehicle. The driver was taken into custody on suspicion of driving under the influence. Both the driver and passenger were evaluated by Westchester Fire Paramedics and transported to a local hospital with non life threatening injuries. A 35-year old male from Orland Park was cited for Leaving the Scene of a Crash, Driving under the Influence, and Alcohol Concentration in blood is 0.08 or more. The 35-year old was released with a Citation & Notice and giving a court date at the 4th District Cook County Courthouse in Maywood, Illinois.
